**INFORMATION REGARDING TUITION FEE**

## **TUITION FEE FOR N.R.I. (2016-17) QUOTA**

The tuition fees for total duration of course (i.e. 09 terms) will be US \$ 1,05,000 (US Dollars One Lakh and Five Thousand Only) as per the permission of competent authorities.

The above fees shall be payable in five (05) equal instalments of US \$ 21,000 (US Dollars Twenty One Thousand Only) per year.

First instalment of tuition fee shall be paid at the time of admission within stipulated time period and thereafter every year in the month of July only as per the details given in the below table.

Tuition fees should be paid in US Dollars only through the NRI account by Demand Draft/ Electronic Transfer in favour of "Commissioner, Surat Municipal Corporation" payable at Surat, Gujarat.

**The time schedule for the payment of tuition fee is fixed and it is solely the responsibility of the student to remit the said tuition fee without fail as per schedule. No further communication/reminder/intimation will be given regarding this. It may be further noted that failing to pay the tuition fee within the stipulated time frame will attract penalty and punitive action as per rules.**

***If the study is prolonged:*** If a student fails in any subject or all the subjects in any semester, he/she shall have to pay repeater fee per subject as per the rules of Government of Gujarat and Veer Narmad South Gujarat University (VNSGU), Surat.

During the course of study of four and a half (4 1/2) years, if the term is extended due to any reason, the student shall have to pay additional tuition fees of 25 % for each extra term. Permission will only be accorded to appear in the university examination after clearing of all the dues. The above said fee is subject to revision/alterations by the competent authority.

## **HOSTEL FEE (2016-17 BATCH)**

Separate hostel accommodation facilities for boys and girls are available. The hostel fee/charges are Rs. 15,000 per annum. The above hostel fee is subject to revision/alterations by the competent authority from time to time.

The hostel fees is under the revision process as soon as the revision of fee is decided and the hostellers would be informed and the hostellers shall have to pay the revised hostel fee. In addition, a onetime refundable fee of Rs. 5,000/- is being collected as security deposit.

## **REFUND OF FEE (2016-17 BATCH)**

Generally no refund of fee is permitted on account of withdrawal/absence from the institute or other reasons once candidate is admitted to any course of study.

- 1) A refund claim may however be admitted on merit after due consideration of the request subject to approval of the competent authorities if,
  - a. A candidate who was admitted provisionally is declared not eligible for admission by the University afterwards in which case 90% of the tuition fees will be refunded or
  - b. A student dies during the course in which unutilized proportional amount of tuition fees @ U.S. \$ 21,000/- for each unutilized term will be refunded. However, no part of other charges or fees will be refunded.
- 2) No fees / charges will be refunded if a student leaves the course midway (i.e. after completion of the admission procedure) for any reason whatsoever or is expelled from the institute for any reason whatsoever or is prohibited by the university to pursue his studies further for any reason.
- 3) All refunds will be made in accordance with the Foreign Exchange Regulations.
- 4) All refunds will be processed upon receiving approval from appropriate competent authorities. Refunds will be made only after the candidate has surrendered the ID card, original fee receipt and the dues clearance certificate.
